Regular Meeting

September 9, 2019

Mayor Laggis opened the monthly meeting at 7:05. In attendance were Mayor Laggis as well as Councilmen Frank Carden, and Kenny Wright. Councilman Jack Gilson was absent. The minutes from August's meeting were approved with Councilman Wright making the motion and Councilman Carden seconding it. Motion passed. Mayor Laggis officially congratulated Councilman Wright and Carden for qualifying for another four year term as they had no opposition.

Financial Report

See attached. Councilman Carden made a motion to approve the financial report as given and he was seconded by Councilman Wright. Motion passed.

Old Business

1. Intersection Update – GDOT was responsive to the roundabout with the R-Cut. The goal is to keep it on budget and not overbuilt. Newest plans have it go closer to the store. One of the versions being considered shows an entrance on 92 for the subdivision which might help.

Mayor Laggis said that he would like the project to be reassessed once the roundabouts near Antioch and 92 are completed. Councilman Wright asked if there was a timeline to use the funds and was told no, just that the money had to be earmarked.

2. Zoning Administrator Options – Mayor Lggis reached out to Bill Johnston for some suggestions. He was given the name of Richard Osborne, who heads up a group of Z.A. The Mayor contacted him and was supplied with 5 contacts. Mayor Laggis will ask Mr. Johnston if he knows any of the 5 and if not, then Mayor Laggis and Councilman Carden will contact and "interview" them. Mayor Laggis will also be meeting with the Mayors of Brooks and Tyrone and will ask them what/who they use and how it is working for them.

3. Community Bulletin Board – Councilman Wright provided a drawing of what he was thinking in regards to a stand-alone board. After some discussion, it was decided to do a board that would be on the outside wall of the building by the parking lot. Councilman Wright will price that out for the next meeting.

4. Other – Mayor Laggis spoke to the bank and set up online banking. There will still be 2 people needed to authorize any payments. There will also be a debit card available for miscellaneous purchases needed to conduct the business of the town.

New Business

1. Other – Deputy Fire Chief Barlett retired and Jeff Hill will be taking over for him on a temporary basis. Jimmy Hall, the Fire Marshall, will also be retiring. The public safety breakfast will be on Sat. Dec 7 at 9:00am. The WCC has passed its fire inspection. Mayor Laggis will let clerk know when WCC is rented, so if there is a time that the Mayor is unavailable and if there is an inquiry, the clerk could let them know if it is available.

With no more business to come before the council, the meeting was adjourned at 8:05.
