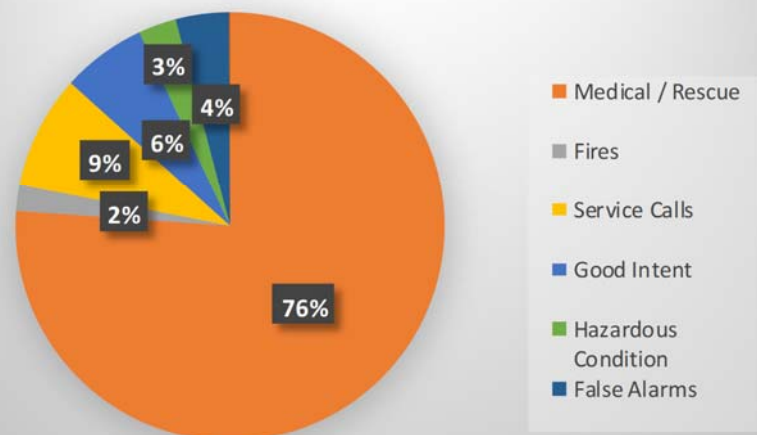

## Fire/EMS Training

The Fire/EMS Training Section provides initial and recurrent training across all disciplines and designs programs for professional development of employees. The Section interfaces with local, State and Federal agencies that govern and monitor Fire / EMS Training to ensure compliance.

## Emergency Management Agency

The Fayette County Emergency Management Agency coordinates the county's mitigation, preparedness, response, and recovery efforts utilizing an all-hazards approach. We work with local, state, and federal governments, in partnership with the private sector and faith-based community, to prevent and respond to natural and man-made disasters. Responsibilities also include maintaining Fayette County's eligibility to receive grants and reimbursements resulting from presidentially declared disasters.

Tropical Storm Irma—Response & Recovery

79 Weather Related Special Advisories or Warnings; Included were: Flood Warnings of Line Creek/Flint River, Multiple Thunderstorm/Tornado Warnings, and a Winter Storm Warning.

Participation in Georgia Emergency Management Agency Winter/Ex tabletop exercise.

Assisted 2 private dam owners with an Emergency Operations Plan to meet new Georgia Safe Dams requirements.

Held 2 Fire/EMS Youth Camps in cooperation with Parks and Recreation.

Assisted Region 4 Department of Public Health with Closed POD recruitment efforts.

## Fire Marshal's Office

The Fire Marshal's Office promotes safety and awareness to reduce the loss of lives and property to the citizens and businesses through public education, life safety inspections, fire investigations, building plan reviews and fire extinguisher training.

These missions are achieved by conducting fire safety education to all 3<sup>rd</sup> grade students within the unincorporated Fayette County Schools. Also, provide public education to senior organization groups, fire extinguisher training to business owners and to the public within the community. Fire safety inspections are also conducted on all commercial buildings within Fayette County to insure life safety standards are met.

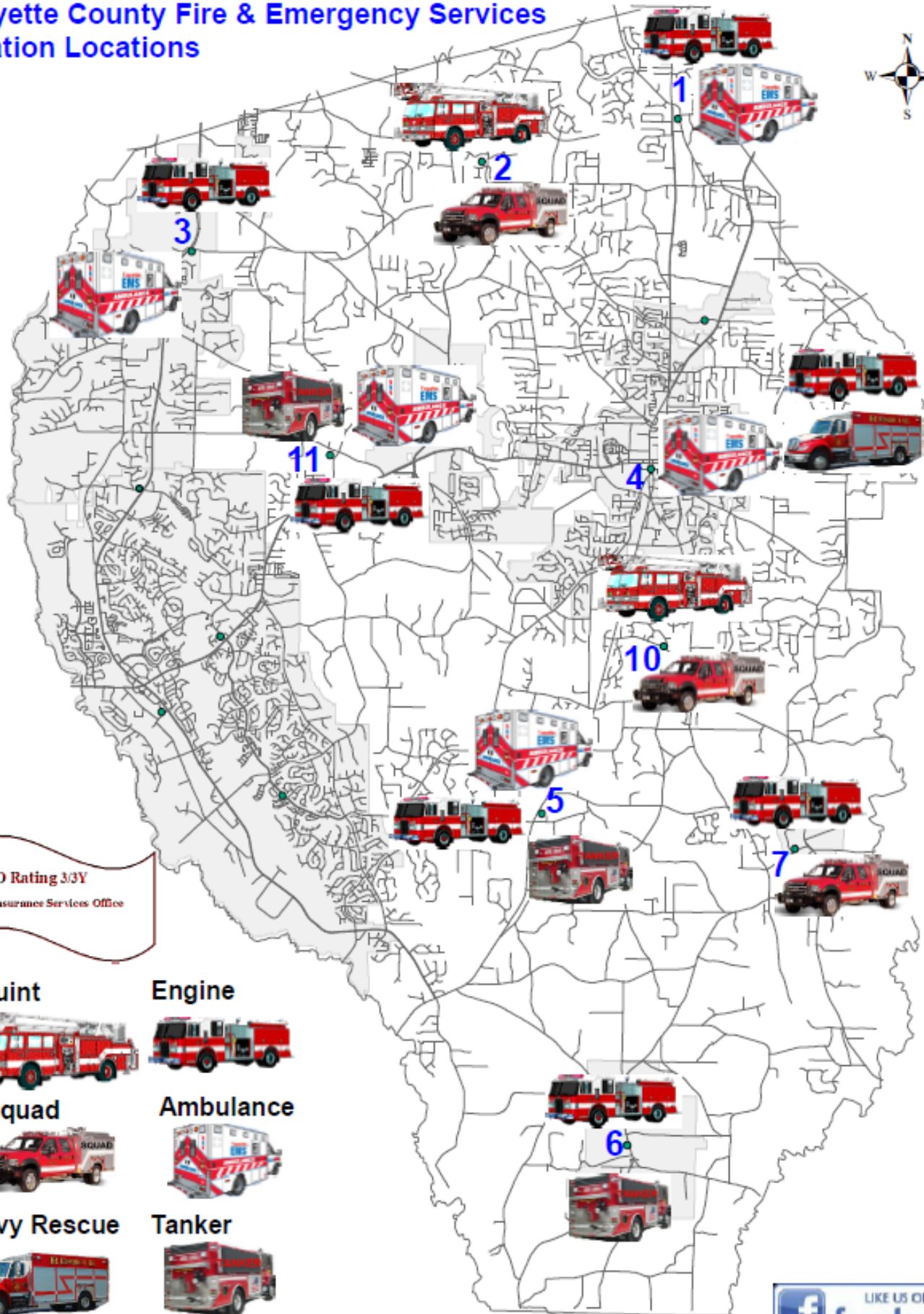
