TOWN of WOOLSEY

Regular Meeting June 11, 2018

Mayor Laggis opened the monthly meeting at 7:00. In attendance were Mayor Laggis, as well as Councilman Wright, Councilman Gilson and Councilman Carden. The minutes from May's meeting were approved with Councilman Gilson making the motion for approval and he was seconded by Councilman Wright. Motion passed.

Financial Report

In the building account there was interest of \$9.44. Expenses were Water – 18.48, and Gary Laggis (repayment for furnishings) - \$1692.90. The ending balance was \$71,221.35. In the operating account incoming was the following: Alcohol Tax – \$548.10 and Interest - \$1.39. Expenses were the following: Clerk - \$300.00, Lawn care - \$300.00, Rent - \$50.00, Strategic Planning Initiative - \$1200.00, Legal Ad - \$20.00, Cherie Morgan - \$200.00 and ATT - \$60.29. The ending balance was \$75,872.88. Councilman Wright made the motion to approve the financial report and was seconded by Councilman Carden.

Old Business

- 1. Building Update The storage trailer will be removed this week. The electrician will be out this week to hang the ceiling fans and EMC will be out within the next 3 days to remove the temporary pole and put in permanent one. Once that is done, the floor can be laid since it needs to be climate controlled. We should have a mockup for the sign within the next day or so. Mayor Laggis met with Lee Pope at the Water Department and went through the 24 boxes of artifacts that were found at Lake Horton. Many appeared to come from the Creek Indians who used to live here. These artifacts include tools, pottery and arrowheads. If the Council wants to display these at the building, a request has to be made at a water commission meeting.
- 2. Recommended Changes to Zoning Ordinance Bill Johnston has been sending Mayor Laggis and Councilman Carden suggestions on changes to the Ordinance. Mayor Laggis asked the other 2 Councilmen if they want to see rough draft as it is being worked or wait until a Council meeting. It was decided to just wait for the meeting.

New Business

- 1. QLG Status Woolsey has been deemed a qualified local government.
- 2. Other There were discussions about having a plaque hung in the building in dedication to the Ballard and Norton families for their generous donation of the building and land. Also, the potential problem with overflow parking at the building will have to be addressed at a later time. And finally, it has come to the Council's attention that a 6 million+ sq foot industrial development is being considered in Henry County near the Atlanta Motor Speedway, which may very well impact traffic and noise in Woolsey. Councilman Wright commented that it might be a good time to consider the historic preservation idea.

With no more business to come before the council, the meeting was adjourned at 8:11 pm.
